OFFICIAL RULES AND CONDITIONS OF THE DRAWING ("Rules")

I. Organizer of the drawing, purpose of the drawing

- 1.1. The organizer of the drawing ("Drawing") is the Limited Liability Company "Avtovin-Robotics" ("Organizer"), registered according to the legislation of Ukraine and located at Ukraine, 58023, Chernivtsi oblast', city of Chernivtsi, Komunalnykiv street, building 3A.
- 1.2. The Drawing is conducted to generate interest and consumer demand for the Organizer's products among consumers.
- 1.3. The Drawing is not a lottery, gambling, or other risk-based game, and the participants of the Drawing do not bear financial risks associated with participation in the Drawing. The procedure for conducting the Drawing is not associated with participants making any payments. The Organizer does not receive any compensation from the Participants for participation in the Drawing.

II. Duration and Venue of the Drawing

- 2.1. The Drawing will take place from 09:30 on April 16, 2024, to 15:00 on April 18, 2024 (or April 16-17, 2024, from 09:30 to 17:30, April 18, 2024, from 09:30 to 15:00).
- 2.2. The Drawing is held within the framework of the Intertraffic Amsterdam 2024 exhibition, located at RAI Amsterdam, Europaplein 24, 1078 GZ Amsterdam, The Netherlands, booth No. 01.263.
- 2.3. The Organizer may change the timing and venue of the Drawing due to significant changes in circumstances that the Organizer could not have foreseen.

III. Prize Fund of the Drawing

- 3.1. The prize fund of the Drawing consists of 1003 (one thousand three) prizes ("Prizes") 1000 (one thousand) Prizes and 3 (three) Super Prizes:
 - 3.2. Prizes:
 - Custom license plate 200 (two hundred) units;

- 50% discount certificate ("Discount Certificate") for a set of equipment for license plate production, which includes an embossing press model High with software version AV-2 and a double row hot stamping machine ("Equipment Set") -1 (one) unit;
- 25% discount certificate for a set of equipment for license plate production, which includes an embossing press model High with software version AV-2 and a double row hot stamping machine ("Equipment Set") -1 (one) unit.
- 3.4. The prize fund of the Drawing is limited and consists of the quantity specified in clause 3.1.
- 3.5. The Organizer's liability for the issuance of Prizes is limited solely to the aforementioned quantity of Prizes.

- 5.1. Rights of the Drawing Participant.
 - Participate in the Drawing in accordance with these Rules;
 - Familiarize oneself with the Rules;
 - Timely receive information about changes to the Rules;
 - In case of being declared a Winner, receive a Prize from the prize fund of the Drawing.
- 5.2. Obligations of the Participant:
 - Fulfill the conditions of these Rules of the Drawing;
- In case of being determined as a Participant of the Drawing eligible to receive one of the Super Prizes, the Participant is obliged to perform all necessary actions specified in the Rules of the Drawing.

VI. Rights and Obligations of the Drawing Organizer

- 8.1. - 8.2. The person responsible for the Drawing randomly selects 3 (three) lottery tickets from the drum, which contain the contact information of the Participants, and announces the information about the winners.

X. Procedure for Using the Discount Certificate

- 10.1. Winners who receive a Discount Certificate as a result of the Drawing will be able to receive a discount on the Equipment Set.
- 10.2. The use of the Discount Certificate and payment of the remaining cost of the Equipment Set not covered by the Discount Certificate must be made within 30 (thirty) calendar days from the moment of publishing the results of the Drawing of Super Prizes on the website https://avtovin.com.ua/.
- 10.3. If the Winner does not use the Discount Certificate within the period specified in clause 10.2, it will be voided.
- 10.4. Winners who purchase equipment using the Discount Certificate are responsible for all costs associated with the delivery of the Equipment Set.
 - 10.5. Delivery is carried out in accordance with the Incoterms 2020 rules, EXW, Chernivtsi.

XI.Organizer's Liability Limitations

11.1. Replacement of Prizes with cash equivalents is not allowed. Prizes are not subject to exchange or return.
